

## **2012 MEMBERSHIP CLASSIFICATIONS**

### **SOCIAL A MEMBERSHIP:**

Unlimited use of the clubhouse facilities for the bondholder, spouse, and unmarried children under 25 years of age, living at home and non-self-supporting. Social "A" members will be permitted to use other club facilities –*six (6) rounds of golf per year* with no charge for green fees (cart fees not included), and also can utilize the pool/tennis facilities four (4) times per year at no charge.

Dues: \$425.00

Capital Fund Fee: \$30.00 per month

Food Minimum: \$60.00 per month

### **SOCIAL B MEMBERSHIP:**

Unlimited use of the clubhouse facilities for the bondholder, spouse, and unmarried children under 25 years of age, living at home and non-self-supporting. Use of other club facilities is not allowed.

Dues: \$205.00

Capital Fund Fee: No Charge per month

Food Minimum: \$75.00 per month

### **POOL AND TENNIS MEMBERSHIP:**

Unlimited use of the pool and the club's 4 tennis courts and clubhouse facilities for the bondholder, spouse, and unmarried children under 25 years of age, living at home and non-self-supporting. Pool and Tennis Members will be permitted to use other club facilities: *six (6) rounds of golf per year* with no charge for green fees (cart fees not included).

Dues: \$1,025.00

Capital Fund Fee: \$30.00 per month

Food Minimum: \$60.00 per month

### **SUMMER POOL AND TENNIS MEMBERSHIP:**

Unlimited use of the pool and the club's 4 tennis courts and clubhouse facilities for the bondholder, from May 15-Sept 15 for the bondholder and unmarried children under 25 years of age, living at home and non-self-supporting.

Dues: \$510.00

Capital Fund Fee: \$30.00 per month

Food Minimum: \$60.00 per month

### **SINGLE GOLF MEMBERSHIP:**

Unlimited golf for the bondholder only and family use of the pool and tennis and clubhouse facilities for the spouse, and unmarried children under 25 years of age, living at home and non-self-supporting.

Dues: \$2,105.00

Capital Fund Fee: \$30.00 per month

Food Minimum: \$60.00 per month

### **FAMILY GOLF MEMBERSHIP:**

Unlimited golf for the bondholder, spouse, and unmarried children under 25 years of age, living at home and non-self-supporting plus use of the pool and tennis and clubhouse facilities.

Dues: \$2,960.00

Capital Fund Fee: \$30.00 per month

Food Minimum: \$60.00 per month

### **JUNIOR MEMBERSHIP**

A Junior Member is classified as an applicant who is under the age of 35 (verification of age is required), has been endorsed by two active members and has received approval by the Membership Committee. Junior Members have no voting privileges until the bond is paid in full. Junior Members will remain as Junior Members until the day of their 35<sup>th</sup> Birthday.

### **JUNIOR MEMBERSHIP – AGES 21-25:**

Family Golf: \$985.00

Single Golf: \$705.00

Pool/Tennis: \$345.00

Capital Fund Fee: \$30.00 per month

Food Minimum: \$60.00 per month

FVCC Bond must be purchased beginning on 30<sup>th</sup> Birthday and must be paid in full on or before the member's 31<sup>st</sup> Birthday.

### **JUNIOR MEMBERSHIP – AGES 26-30:**

Family Golf: \$1,480.00

Single Golf: \$1,055.00

Pool/Tennis: \$ 515.00

Capital Fund Fee: \$30.00 per month

Food Minimum: \$60.00 per month

FVCC Bond must be purchased beginning on 30<sup>th</sup> Birthday and must be paid in full on or before the member's 31<sup>st</sup> Birthday.

### **JUNIOR MEMBERSHIP – AGES 31-35:**

Family Golf: \$1,955.00

Single Golf: \$1,390.00

Pool/Tennis: \$ 685.00

Capital Fund Fee: \$30.00 per month

Food Minimum: \$60.00 per month

FVCC Bond must be purchased beginning on 30<sup>th</sup> Birthday and must be paid in full on or before the member's 31<sup>st</sup> Birthday.

## **SENIOR MEMBERSHIP**

### **SENIOR SOCIAL MEMBERSHIP: 70 AND OVER**

Senior Membership is available for individuals 70 years of age and over. Any active member who reaches the age of 70 prior to November 1<sup>st</sup> will receive a 10% discount of current social "A" dues. There is no discount of monthly fees or capital assessments. Age verification by copy of driver's license or other documentation is required.

### **SENIOR GOLF MEMBERSHIP:**

The following Senior Membership (golf membership only) is available to any active member that reaches the age of the below categories by November 1<sup>st</sup>. This reduction in dues applies to the bondholder. Age verification by copy of driver's license or other documentation is required.

**Senior Member- Ages 70-74:** 10% reduction in current golf dues.

**Senior Member Ages 75-79:** 15% reduction in current golf dues.

**Senior Member at Age 80 and with 25 years of membership (which does not need to be continuous):**

15 % reduction in current golf dues. The monthly minimum and capital fund assessment would be frozen henceforth when age and years of membership are met.

**NON- RESIDENT MEMBERSHIP:** Membership available to those living outside of 35 miles from FVCC who are not current members. Unlimited use of the clubhouse as a social member and limited to four (4) rounds of golf per month.

Non-Resident: \$206.00 per year

Capital Fund Fee: No Charge per month

Food Minimum: No Charge per month
